AG Twin Brook Capital Income Fund (TCAP) Portfolio Update



Performance Commentary

TCAP's portfolio has been built with the objective of generating attractive, consistent total returns to withstand market conditions. Supported by our dedicated team of 110+ professionals and our extensive underwriting process, we believe our portfolio remains healthy, resilient, and well positioned for the uncertainty ahead.

Private Credit has continued to offer a strong value proposition to private equity sponsored borrowers as evident by the volume of deals seeking execution in the private vs. syndicated markets throughout 2023. The factors driving the preference for private market financing have been the speed of execution, reliability of terms, and the ability of the private markets to underwrite more complicated transactions.

Given the unexpected and consistent macro headwinds, a few key components of our all-weather strategy are continuing to shine such as (1) the leadership role we play in transactions, 96% Admin Agent or Co-Lead Arranger on the loans in TCAP, (2) our ability to drive lender protections⁷ given this role and (3) our focus on the lower middle market where we believe the competitive landscape allowing for greater pricing power and more friendly lender terms, supporting our ability to produce favorable risk-adjusted returns.

TCAP's \$1.4 billion investment portfolio as of December 31, 2023, was comprised of 198 portfolio companies operating across 37 different sectors, with a weighted average yield at fair value of 11.7%, weighted average EBITDA of \$19.3 million, and a weighted average loan to value of 40%. TCAP remains focused on first lien, floating rate investments, with first lien senior secured debt and floating rate loans each representing 100% of the Fund's debt portfolio.

In the fourth quarter of 2023, TCAP generated a total return of 2.4%⁸ and paid total distributions of \$0.66 for Class I shares. TCAP was launched on January 1, 2023, and has since generated an inception to date return of 8.5%⁶ and an annualized distribution yield of 11.4%⁹ for Class I Shares. Performance has been supported by rising base rates, but more importantly our focus on transactions that have a demonstrated track record of cash flow generation.
