

# TPG Twin Brook Capital Income Fund (TCAP) Portfolio Update

TCAP is a public, non-exchange traded perpetual life business development company with the objective of generating attractive, consistent total returns – predominantly in the form of current income and, to a lesser extent, capital appreciation – by targeting investment opportunities with favorable risk-adjusted returns.



## **Performance Commentary**

Sponsored middle market lending volume, including both syndicated and direct activity, amounted to approximately \$95 billion<sup>9</sup> through the second quarter of 2025, a nearly 15% increase over the first half of the prior year. We believe the lower mid-market continues to offer a compelling investment opportunity, accounting for nearly 40% of sponsored M&A quarterly volume, greater than the core and upper mid-markets for the quarter, despite smaller deal sizes. As a result, we continue to believe the opportunity set in the lower mid-market remains robust, especially given conservative loan structures and lender protections afforded.<sup>10</sup>

TCAP's portfolio has been built with the objective of generating attractive, consistent total returns across market cycles. Supported by our dedicated team of nearly 130 professionals and diligent underwriting process, we believe our portfolio remains healthy and resilient. A few key components of our all-weather strategy are continuing to shine such as (1) the leadership role we play in transactions, nearly 100% Admin Agent or Co-Lead Arranger in TCAP's investments, which is a testament to our strong relationships and established origination platform, (2) our ability to source attractive deal flow, and maintain high selectivity of <4% of screened opportunities annually and (3) our focus on the lower mid-market where we believe the competitive landscape allows for greater pricing power and more friendly lender terms, supporting our goal of producing favorable risk-adjusted returns.

TCAP's \$3.6 billion investment portfolio as of June 30, 2025, was comprised of 247 portfolio companies operating across 43 different sectors, with a weighted average yield at fair value of 9.9%, weighted average EBITDA of \$17.9 million, and a weighted average loan to value of 40%. TCAP remains focused on first lien senior secured debt representing 100% of the Fund's debt portfolio. TPG Twin Brook expects to originate 100% of its loans as floating rate investments.

In the second quarter of 2025, TCAP generated a total return of 2.7% and paid total distributions of \$0.66 for Class I shares. TCAP was launched on January 1, 2023, and has since generated an inception to date return of 9.8% and an annualized distribution rate of 10.9% for Class I Shares. Performance has been supported by rising base rates, but more importantly our focus on transactions that have a demonstrated track record of cash flow generation.
